1. Collective monograph No. 1

Requirements to the paper:

Font: Times New Roman, size 12, spacing 1, margins of 20 mm on all sides.

Formulation:

1st line – title of paper (all capital letters, bold). Alignment – on the centre.

2nd line – blank line.

3rd line – full name of author / co-authors (italic). Alignment – on the left.

4th line – work place. Alignment – on the left.

5th – the city and country (italic). Alignment – on the left.

6th line – e-mail of author / co-authors (italic). Alignment – on the left.

7th and 8th lines – blank lines.

from 9^{th} line – abstract in English and in the language of the article (up to 10 lines), key words in English and in the language of the article (3-6 words) and text of paper (with indent 1 cm). Alignment – on the width.

Size: 20-25 thousand characters (approximately 7-8 pages).

The number of co-authors is up to 3.

The registration fee for <u>in-person</u> participation in the conference is 230 PLN (1500 UAH / 50 EUR / 55 USD). In the case of in-person participation in the conference by two/three co-authors of an article, the organizational fee for the second/third co-author is 100 PLN (650 UAH / 20 EUR / 25 USD). The registration fee for <u>remote</u> participation in the conference is 125 PLN (890 UAH / 30 EUR / 35 USD) and is not dependent on the number of co-authors (1-3 co-authors). The registration fee is used to partially cover the costs of organizing and conducting the conference and publishing the collective monograph.

2. Collective monograph No. 2

It is formed in accordance with the requirements of the Licensing conditions for the conduct of educational activities https://zakon.rada.gov.ua/laws/show/365-2021-%D0%BF#Text (subparagraph 3 of paragraph 38 – "availability of an issued textbook or study guide (including electronic) or monographs (with a total volume of at least 5 author's sheets), including those published in coauthorship (with a volume of at least 1.5 author's sheets for each co-author)".

Requirements to the paper:

Font: Times New Roman, size 12, spacing 1, margins of 20 mm on all sides.

Formulation:

1st line – title of paper (all capital letters, bold). Alignment – on the centre.

2nd line – blank line.

3rd line – full name of author / co-authors (italic). Alignment – on the left.

4th line – work place. Alignment – on the left.

5th – the city and country (italic). Alignment – on the left.

6th line – e-mail of author / co-authors (italic). Alignment – on the left.

7th and 8th lines – blank lines.

from 9th line – abstract in English and in the language of the article (up to 10 lines), key words in English and in the language of the article (3-6 words) and text of paper (with indent 1 cm). Alignment – on the width.

Literature design – according to the APA standard (https://apastyle.apa.org/style-grammarguidelines/references/examples).

Size: 1.5 author's sheets – 65-70 thousand characters (approximately 17 pages).

The article must be one-person!

The registration fee for <u>in-person</u> participation in the conference is 350 PLN (2500 грн. / $80 \ \varepsilon$ / 85 USD). The registration fee for **remote** participation in the conference is 250 PLN (2000 грн. / 60 € / 65 USD). The registration fee is used to partially cover the costs of preparation and holding of the conference, and publishing of Collective Monograph.

- application form (for each author / co-author is filled with a separate application);
- an article (section) for a collective monograph.
